

Public posting of annual reports online (JOLP) - help

Viewing annual report data is a **free service**. In the interest of protecting the security of the public database information system, the daily limit per username is 20 views of business entity data.

Login:

To access data:

- log on as a registered user (in the section “Login” enter the username and password you received upon free registration),

- enter one or more search criteria, choose number of hits (default 20) and click “Search”,

- choose one of the business entities from the list (search results),

- type the access code in the appropriate box,
- tick the confirmation box “I agree to the Terms and Conditions” and
- click “Send”.

The access code is automatically generated by JOLP and it changes with every access!

Use of the viewing service:

You may access the annual report and its parts by clicking the links (e.g. Balance Sheet, Consolidated annual report etc).

The annual reports are published in the form of:

1. spreadsheets (balance sheet and income statement), prepared using data from the database, and comments to the financial statements,
2. PDF files,
3. scanned document images (TIF).

1) ANNUAL REPORTS IN SPREADSHEET FORMAT

An annual report published in the form of a spreadsheet is displayed directly on the website.

You can print either an individual form or the whole annual report. Clicking the “Print” button opens a new tab where you can print or save the document. Clicking the “Print all” button automatically creates a PDF file with related forms you can save or print.




